The Micromoog "Sogga" and Tom Rhea's Sojourns to Australia - 1974 & 1975

My memo to Chuck Hendry *et al* (January 27, 1975) re Micromoog production numbers was assiduously ignored, of course. I indicated that we had developed a fine little synthesizer and should open the production floodgates. **Nope.**

I challenged Norlin's decision to build only ten (10) units for a "marketing study" by stating that I could sell that many immediately. Subsequently I did as much, by traveling to Manny's (NYC), Sam Ash Music (Long Island, NY), and Chuck Levin's Washington Music Center (Wheaton, MD.) At each dealer three (3) Micromoogs had been brought in. It took me exactly one (1) day per each dealer to sell all nine (9) of them. I stood on those dealers' floors until it was done.

So, OK. Open the floodgates, right? **Nope.** The decision came down that there would be 103 units in the first production run. Wow! I told Norlin's brass I would sell that entire production run at the next NAMM show. In fact, I *did* sell all 103 of those Micromoogs to Rose Music Pty. of Australia at that NAMM show. In fact, we trounced ARP's AXXE synth at that show, which I loudly and somewhat injudiciously proclaimed very publicly to ARP's reps and their brass!

Now, Alan Rose immigrated to Australia as a young man with hardly anything to his name but the clothes on his back, and had built a sizeable empire of music dealers there. One whose size was commensurate with Norlin's dealers in USA, given relative differences in total populations.

Mr. Rose was a man of vision—he could see that synthesizers were the coming thing. In fact, I recall his browbeating one of his Company Principals about this in a meeting we had, saying: "... now look here—he (Tom Rhea) is an expert—listen to what he is saying to us!" This was during the first visit I made to Australia (see exhibit below: letter of September 23, 1974). During that several weeks long visit I sold many Moog Sonic Six and Minimoog synthesizers from Perth to Sydney to Melbourne. Rose wangled me into teachers' conferences, the leading academic institutions as a speaker, etc. In a word, they did a fine job of it! And so did I...

Due to the confidence I had garnered with Rose Music during that initial visit to their country, Rose Music Principals visiting that NAMM show took my word for it that I could sell these Micromoogs throughout Australia. They signed for all 103 of them!

But of course, we had missed the benefits of "scale," i.e. by producing a larger number of units! Even so, Scott's little Micromoog became a *roaring* success, despite Norlin's early "misgivings."

Indeed, another trip for me to Down Under (Australia) was scheduled for 1975 (see resulting letter of 9 October 1975 below).

These letters are followed by a few photos of sales events in Australia. The gent on the left was Mr. Brian Brown of Rose Music . . . who could mimic all the local accents and dialects of the entire British Isles. What an ear he had! And I enjoyed oysters Mornay most days while there!
